



Key EAD milestones for Posts (designated postal operators)







Progress in 2017-2021 with regard to EAD

- 195 DOs are sending PREDES (Feb' 21)
- 190 DOs are receiving ITMATT (Feb' 21)
- 158 DOs are sending ITMATT (Feb' 21)
- DSAs, operational, IT and equipmentrelated issues are the biggest obstacles to faster adoption




Evolution of ITMATT Dec 2017 - Feb 2021








UPU Global Postal Model for EAD and PLACI (pre-loading advance cargo information)





Common Fund EAD Project

- 143 DOs participating in project
- Nr of DOs sending ITMATT
 - Increased from 44 to 103
- ITMATT & PREDES as % of total volume
 - Increased from 15% to 50%

CF EAD Project: Data capture and transmission: national action plan for Phase 1

Focus on ITMATT and PREDES (S9-10) in Phase 1: proposed 11 steps

- 1 Prioritize top 5-10 partner destination/transit DOs (in terms of volume/requirements): Using EAD Compendium (list of contacts and requirements), Quality Control System (QCS). 2 Sign DSAs as required with top 5-10 partner DOs (in terms of volume/requirements). Enforce use of S10 and CN 22/CN 23 on all small packets at post offices. **STRATEGIZE PLAN** 3 4 Train staff to review correct completion of CN 22/CN 23/CP 72 at post offices: Use 2 WCO-UPU data capture guidelines for this purpose. Roll out CDS/CDS.POST online training and production. 5 EXECUTE SUPPORT 6 Ensure CDS.Web manual checks and data capture capability at offices of exchange: By mail class (EMS -> Parcels -> Small packets); 3 By partner (start enforcing compulsory EAD with top 5-10 partner DOs in terms of volume). IMPLEMENT 7 Enforce IPS scanning of all small packets at dispatch at offices of exchange (PREDES S9-S10). COMMUNICATION 8 Plan the introduction of pilot post offices with capture of customer (sender) data. TIME MANAGEMENT 9 Conduct procurement for pilot post offices: SCHEDULING BUDGETING Analyze providers and obtain offers, invoice and equipment; Submit documentation (offers and invoices).
- 10 Train staff at pilot post offices to link customer data with S10/ITMATT.
- 11 Install equipment at pilot post offices and roll out pilot.



Possible EAD deployment strategy at offices of exchange

- 1 Roll out CDS/CDS.POST online training and production.
- 2 Ensure CDS.Web manual checks and data capture capability at offices of exchange:
 - By mail class (EMS -> Parcels -> Small packets);
 - By partner (start enforcing compulsory EAD with top 5-10 partner DOs in terms of volume).
- 3 Enforce IPS scanning of all small packets at dispatch at offices of exchange (PREDES S9-S10).






Pilot post office concept – declaration data capture at source

Manual data capture : **Handwritten forms** — Data capture at source : **Printed Labels**






Pilot post office concept set-up
